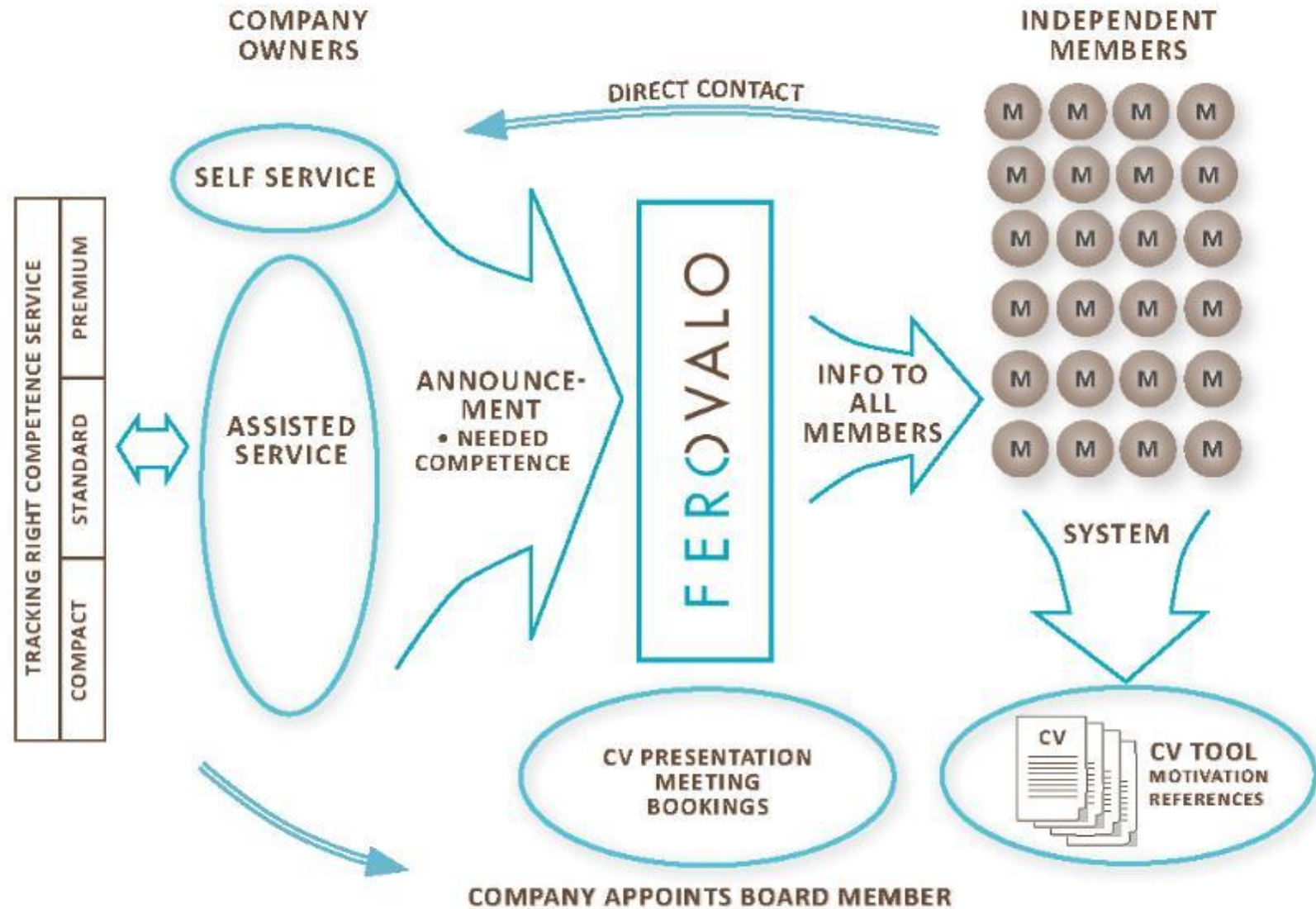

- Ferovalo will announce the board member need to its' members. Members receive email and information is in Ferovalo system. Announcement may be with the company name or anonymous. If anonymous, candidate CVs created by Ferovalo CV Tool in system are presented anonymous to the client.
- Interested members apply through the system.
- Ferovalo checks applicants references **prior presenting** candidates to the company representatives.
- Ferovalo **presents all interested candidates** to the company in face-to-face meeting or in Skype. If face-to-face meeting is outside Helsinki region travel expenses are added to the cost.
- The company representatives selects candidates for first discussion and gives times for those meetings. Meetings will be either face-to-face, phone or via Skype. Ferovalo organizes the meetings.
- Ferovalo books meeting with selected candidates and the company representatives and sends to candidates possible additional information about the company. Also meeting time for feedback with Ferovalo after interviews is booked.

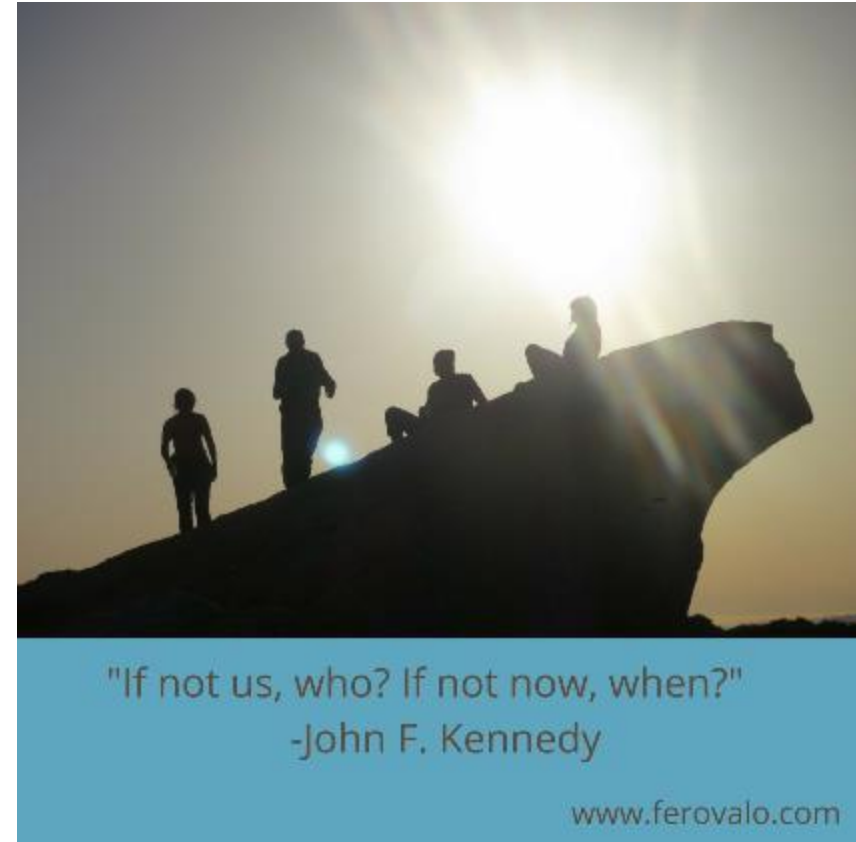
